

## PSH Football Booster Club

Board meeting and general meeting, Jan. 11, 2010

Meeting place: PSH Library

The 2009 Board met at 6:30, prior to the general meeting for discussion on the general meeting. It was decided that the primary purpose of the meeting was to discuss fundraising and electing new board members. Attending was Travis Blevins, Norma Jean Laurent, Lisa Dwyer, Kim Niemuth and Angela Harman.

The general meeting began at 7:00, a list of attendees attached.

There was much general discussion of fundraising and education of limitations the Booster Club has. Dollar amounts were given out on basic expenditures to run the football program. The following points were made:

- The football program receives only \$6000 from the school district
- Pre-game meals for Varsity games alone are \$6000
- Jr. Pat's are the largest fundraiser and largest expenditure
- Other sports/clubs have signature fundraiser events that are sustainable year after year. The Booster Club would like to designate a signature event.
- The Patriot Card and Rent-a-Patriot will be coach driven fundraisers and not coordinated through the Booster Club.
- \$15,000 is the determined goal to raise in total fundraising excluding Jr. Pat's.
- Buffalo Wild Wings night to take place again. We did not make a lot of money, but it was a fun night for all involved.
- 2 sub-committees were formed to explore the ideas of a BBQ competition and Men's poker night.

Two co-parent reps are still needed for the incoming Freshmen, class of 2014. Dave McKay, an 8<sup>th</sup> grade parent will try to help recruit. A separate Grade Rep meeting will take place soon.

The next general Booster Club meeting is May 3<sup>rd</sup>. Prior to that time, an informal email survey will be sent out to get some feedback and "take a pulse".

A 501C status has been researched. It would mean a designated Board member to maintain. Not realistic at this time with the amount of money we raise, but we could have a potential to raise more with a 501C designation. No further determination at this time.
